



AMT Privacy and Consent Policy for Competitions and Programs

- A. The Australian Maths Trusts ABN 39 120 172 502 (referred to as “**AMT**”, “**Our**”, “**We**” or “**Us**”) delivers a number of mathematical competitions every year including, but not limited to, the Kangourou sans Frontières (**KSF**), the Oxford University Computing Challenge (**OUCC**), the Australian Mathematics Competition (**AMC**), the Computational and Algorithmic Thinking competition (**CAT**), the Maths Challenge Program, the Maths Enrichment Program, the Australian Intermediate Maths Olympiad (**AIMO**) and the Australian Informatics Olympiad (**AIO**). Unless notified by AMT otherwise, your consent to participate in any mathematical competitions delivered by AMT is governed by this Privacy Consent Form.
- B. The AMC and CAT are delivered both in paper and online formats.
- C. The KSF, OUCC and AIO are delivered online only.
- D. The AIMO, Challenge and Enrichment are delivered in paper format only with marking uploaded onto the platform.
- E. Delivery of some of our competitions takes place through a provider based overseas.
- F. Our competitions are delivered in accordance with the AMT’s Privacy Policy. Click [here](#) to access this policy.
- G. As per Clause 4 of the AMT Privacy Policy, and the Australian Privacy Principle 8, we must gain consent from relevant individuals for the disclosure of personal or sensitive information to our overseas competition provider.
- H. Schools entering any of our competitions must first gain consent from each student’s parent/guardian for student participation and disclosure of personal information prior to registering and paying for the competition.
- I. Eljakim Information Technology BV, an online provider platform based in the Netherlands, collects and stores each student’s personal information and each student’s results from our competitions on their online platform if the student completes any competition/s. Our competition servers are physically located in Australia, however in the event of downtime or outage we will revert to a server based in the Netherlands. The personal information and results are not used by Eljakim Information Technology BV for any other purpose than competition processing and competition analysis. AMT uses personal information in accordance with our Privacy Policy.
- J. To help teachers with this consent process, we have provided a Privacy and Consent Form below to download and distribute to parents/guardians.
- K. Where consent is not obtained, the student’s school indemnifies the Australian Maths Trust for any liability stemming from the school’s non-compliance with this Privacy and Consent Policy.

Participation

AMT also publish the results of its competitions and activities on its website, which may include information such as the student's name, school, school year, state, award and score as well as the names of award winners and/or medalists.

AMT has advised that the personal information is kept in their competition servers which are physically located in Australia, however they use an online provider platform based in the Netherlands for competition processing and analysis. Back-up servers are located in the Netherlands. AMT deliver the competitions, and use the personal information, in accordance with the AMT's Privacy Policy.
